- 5. AF FORM 24
- 6. Last 3 evaluations without gaps in evaluation periods. Updated AF Form 77 is required in your personnel record, IAW DAFI 36-2406, to administratively cover the gap period. No exceptions.
- 7. Air Force Fitness Assessment: official printout from myFitness with passing and current test.
